Pharmacy Appeals

Providers have the option to submit an appeal request on behalf of a member for a pharmacy prior authorization denial if they disagree with the UM decision. A provider has 60 days from the date of the prior authorization decision to submit an appeal on behalf of the member. Fax to MPC Member appeals at: 1-866-831-0790

Member Pre-Service Appeal

MPC requires a formal written request to reconsider a medical decision. Medical records should be attached.
